#### DIRECTIONS FOR USE

IMPORTANT: This information is approved as part of the Product Label. All instructions within this section must be read carefully in order to obtain safe and successful use of this product.

Proman® is a selective pre-emergence herbicide for the control of annual broad-leaved weeds and annual grasses in potatoes. The product is mainly absorbed by the roots and transported acropetally within the plant after uptake. Proman® acts by inhibiting photosynthesis in susceptible weeds.

Proman® may be applied on all varieties of potatoes.

# RESTRICTIONS:

- Some transient crop discolouration may occur under certain climatic conditions where heavy rainfall follows application. This transient crop effect is rapidly outgrown and has no effect on crop yield.
- Reduced levels of weed control may occur if application is made to dry cloddy seedbeds or if a prolonged dry period follows application.
- Do not overlap spray swaths.

# TIMING OF APPLICATION

Proman® should be applied following the last ridging and before emergence of the crop and weeds.

# DOSE RATE

Apply Proman® at a dose rate of 3 to 4 litres product/ha (see weed susceptibility table for selection of correct dose). The higher dose rate should be used on heavy soils with a high clay content.

Maximum number of treatments per crop: One.

# WATER VOLUME AND SPRAY QUALITY

Apply in 200 to 600 L of water per ha using a MEDIUM spray  $\sigma$  ality as defined by BCPC.

#### SOIL TYPE

Proman® is recommended for use on all soil type. O timum efficacy is achieved when applied to moist soil. The efficacy are on an or by be reduced when applied on soils with a high organic matter con ent (> 5%).

# MIXING AND APPLICATION

Before using Proman®, ensure the spray equipment is clean. Shake the container well before use.

- 1. Half fill the spray tank with clean water and commence agitation.
- 2. Add the required amount of product to the spray tank and co. plet fring maintaining agitation until spraying is completed.
- 3. On emptying the product container, rinse container hor, while by using an integrated pressure rinsing device or manually, rinsing three times when empty. Add washings to sprayer at time of filling and issues of container safely.
- 4. On preparation of spray solution, use as soon as practically possible.

Never prepare more spray solution than required.

#### COMPATIBILITY

Consult Belchim Crop Protection before tank mixing with any adjuvants or other pesticides.

# SPRAY TANK CLEAN OUT

All application equipment and contaminated clothing should be thoroughly washed/rinsed with clean water three times. After each step of washing drain the sprayer, spray out completely. Ensure that all liquid is removed from the sprayer tank, pump and hoses. Remove nozzles, open tank and drain pump to allow free access of air to all parts of the system. Care should be taken not to rinse contaminated washings from application equipment into waste water

channels

Contaminated cleaning liquids should be disposed of safely according to local regulations.

Operators should read the sprayer manufacturer's instructions before beginning to wash out sprayers.

### RESISTANCE

Metobromuron belongs to the chemical family of ureas and is classified as an inhibitor of photosynthesis. Spraying the same field repeatedly, with products containing active substances from the same chemical family, or having the same mode of action, can lead to the development of resistance.

To reduce the risk, it is recommended to alternate or to tank mix products containing active substances with complementary activity but from different chemical groups or having different modes of action, not only within one growing season but also throughout the crop rotation.

Strains of some annual trasses (e.g. black-grass, wild-oats, and Italian ryegrass) have diveloped esistance to herbicides which may lead to poor control. A strategy for neventing and managing such resistance should be adopted.
