Restrictions/Warnings

CeCeCe 750 should be applied to crops during good growing conditions at the correct timing.

DO NOT apply CeCeCe 750 to any crop suffering physical stress caused by waterlogging, drought or other conditions. Crops with a substantial moisture deficit should NOT be treated.

Care should be taken to avoid overlap of spray swaths.

DO NOT apply CeCeCe 750 when the crop is wet or if rain or frost is imminent.

DO NOT apply CeCeCe 750 to very late sown spring clops

DO NOT apply CeCeCe 750 to crops on soils of the wife tility unless these soils regularly receive adequate dressings of nitrogen fertilizers.

CeCeCe 750 may be applied to wheat, oats and winter barley under sown with grasses and clovers.

Caution is needed if using mixtures of quid nitrogen fertilisers and CeCeCe 750 as scorching may result in certain circumstances.

Do not use straw from CeCeCe 750, eated cereals as a borticultural growth medium or as a mulch.

Height reduction and lodging control

CeCeCe 750 produces shorter, thick ar and stronger stems which can reduce lodging in winter and spring wheat, winter and spring barley, pats, rye and triticale. Yield preservation of lodged crops can occur as a consequence.

Crop Specific Information

CeCeCe 750 can be used on all varieties of the following cereal crops at the rates and timings and water volumes detailed below:

For optimum height reduction in vinter barley, pp), CeCeCe 750 at GS 30. In winter barley the use of Terpal sequentially is recommended for reliable indiging control.

In winter wheat and autumn-drilled spring wheat, rye and triticale the use of Terpal sequentially is recommended for improved lodging convol where the crop is growing vigorously.

Qualified recommendation

CeCeCe 750 may be applied in 100 litres water per hectare although efficacy at this reduced water volume has not been evaluated. Therefore application at 100l itres per hectare is at user's risk with regard to biological safety.

Mixing and Application

Application

Apply as a MEDIUM spray, as defined by BCPC.

Mixing

Never prepare more spray solution than is required.

Three quarters fill the tank with clean water and start the agitation. To ensure thorough mixing of the product, invert the container several times before opening. Add the required quantity of CeCeCe 750 to the spray tank while re-circulating. Add the remainder of the water and continue agitation until spraying is complete.

When tank mixes are to be used, take due note of any instructions given as to the order of mixing. Each product should be added separately to the spray tank and tuny dispersed before the addition of any further product(s).

All tank mixes should be used immediately after mining.

On emptying the container, rinse container there, god, by using a lifet grated pressure rinsing device or by manually rinsing three times. Add washings to tank at time or filling and dispose of container safely.

Sprayer cleaning

Wash sprayer thoroughly immediate, after use, using clean water and following the sprayer cleaning guidance provided by the equipment manufacturer.

Any crop can be planted following normal harvest of an approved cereal crop treated with CeCeCe 750.

In the event of crop failure

In the event of crop failure, lettuce, clover or sunflower should not be planted or drilled within eight weeks.
