INSECT CONTROL

VERIMARK 20SC is a Group 28 anthranilic insecticide used for control of cabbage root fly (*Delia radicum*) in certain brassica vegetables. Activity is by ingestion and contact. Paralysis of the pest occurs within a few hours of exposure and results in cessation of movement and feeding. Final control can take 3-6 days.

VERIMARK 20SC may be used as part of an Integrated Pest Management (IPM) program, which can include cultural and genetic practices, aimed at preventing economic pest damage. IPM principles and practices include field scouting or other detection methods, correct target pest identification, population monitoring, rotation of insecticides with different modes-of-action, and treating when target pest populations reach locally determined action thresholds. There is no information on the effects of VERIMARK 20SC to natural predators, and safety cannot be assumed. Consult your crop adviser to determine appropriate action treatment threshold levels for treating specific pest/crop or site systems in your area.

RESISTANCE

When insecticides with the same mode of action are used repeatedly over several years in the same field, naturally occurring less sensitive strains may survive, propagate and become dominant in that field.
