SCAB 480 SC is a fungicide for control of scab (Venturia spp.) and other diseases on apple and pear.

Specific diseases controlled: Apple scab *Venturia inaequalis*, Canker *Nectria galligena*, Storage rot *Gloeosporium spp.* in apples and pear and Stemphylium vesicarium in pear.

Appy in 1000 L water/ha using tractor mouted/trailed horizontal boom sprayer.

#### Mixing

Half fill the Half fill the spray tank with clean water and start agitation. Pour the required quantity of product into the spray tank. Top up the spray tank with water to the required level. Continue agitation until the tank is sprayed out. Spray immediately after mixing.

Cleaning of application equipment

All application equipment should be triple rinsed with water or a dilute detergent solution. Care should be taken not to discharge the contaminated washings from application equipment into waste water channels. Contaminated cleaning liquids should be disposed of safely according to local regulations.

Risk of resistance and strategy to prevent the emergence of resistence

To prevent the emergence of resistance, we recommend the use of fungicides with different mechanisms of action.

#### **Environmental protection**

To protect aquatic organisms adhere to an unsprayed buffer zone of 25m away from surface water bodies.

The product should not interfere with surrounding vegetation.

With regards to the protection of aquatic organisms, the usage of products on land sloping towards surface waters is excluded. The product cannot be applied on these lands even when using a buffer zone.

#### **Safety Precautions**

#### Personal protective equipment for the preparation and cleaning of application equipment

Wear suitable hand and body protection.

Perform spraying only where there is no wind or during gentle breeze, downwind and away from other people.

Entry to the treated field is possible only from 2 days after application. Do not eat, drink or smoke when using this product.

Remove personal protective equipment and wash hands throughly before eating, drinking or smoking.

Wash protective clothing and PPE after use.

During preparation of application liquid and spraying, do not use contact lenses.

Work with the product is prohibited for pregnant, nursing women and young people. Work with the product is not suitable for allergic people.
