IMPORTANT: This information is approved as part of the Product Label. All instructions within this section must be read carefully in order to obtain safe and successful use of this product.

1. Restrictions/Warnings

Efficacy.

Some soil moisture must be present for **Clayton Launch** to be activated. Best results will be obtained if rainfall occurs within seven days of application.

Residual control may be reduced: - under prolonged dry conditions - on soils with a high Kd factor - where organic matter exceeds 6% - where ash content is high.

DO NOT disturb the soil after **Clayton Launch** has been applied as this will result in reduced weed control. Where cultural techniques which encourage the build-up of organic residues in the surface soil are practised, for several seasons the effectiveness of residual herbicides may be reduced. In such circumstances periodic ploughing is recommended to disperse residues into a greater volume of soil.

Soil types

Clayton Launch may be used on all mineral soil types. DO NOT use on soils with more than 10% organic matter. On stony or gravely soils there is a risk of crop damage, especially if heavy rain falls soon after application. Do not use on waterlogged soil or soils prone to water logging

Seedbed preparation

Trash and straw should be incorporated evenly during seedbed preparation. Seedbed must have a fine, firm tilth. Consolidate loose or cloddy seedbeds before use. Following pre-emergence applications, unconsolidated clods (especially if larger than 75m (3") diameter) may reduce the level of weed control and cause "educe the level of weed control and cause" and to be inadequately covered, which could result in crop damage.

Crop safety

Extreme care should be taken to avoid damage by distance plan outside the target area. Do not apply Clayton Launch to crops suffering from stress, which may be caused for example to, pests, disease, water logging, poor seedbed conditions or previous chemical treatment. Seed should be covered with a minimum of 5 cm of settled soil. Shallow drilled crops should be treated post-emergence. Care should be taken to avoid overlap of spray swaths. Do not soil incorporate. Do not undersow crops treated with Clayton Launch.

Other Restrictions/Warnings.

2.2 Re. istan e management

Strain of so.....annual grasses (eg Black-grass, Wild-Oats, and tallair tyerrass) have developed resistance to herbicides, which may I ar' o poor control. A strategy for preventing and managing such I, sistance should be adopted. Guidelines have been produced by the Weed Resistance Action Group and copies are available from the HGCA, CPA, your distributor, crop adviser or product manufacturer.

3. Crop specific information

Clayton Launch can be used on all varieties of forage maize and grain maize.

Rate: 4 0 l/ha

Water volume: 200-400 litres/hectare.

Timing: Pre-emergence to before 5th true leaf stage (GS 15) of the crop. For optimum efficacy, apply pre-emergence. When applied post-emergence of the maize, apply at any time from the first true leaf (GS 10) to before 5th true leaf stage (GS 15).

Notes: Do not use on maize grown for seed.

Seed must be covered by a minimum of 5cm of settled soil. The use of **Claydon Launch** may affect the full development of crown roots which function only to anchor the plant. This has no effect on the yield of maize.

If application is followed by a period of dry conditions or in situations where very heavy weed populations occur, a sequence of **Clayton Launch** and a product applied post-emergence may be necessary.

4. Following Crops

4.1 Following crops after normal harvest

Before ryegrass is drilled after a very dry season, plough or cultivate to at least 15cm.

For crops other than cereals plough or cultivate to at least 15cm.

4.2 In the event of crop failure

In the event of crop failure the land must be ploughed or thoroughly cultivated to a minimum depth of 15cm to ensure any residues are evenly dispersed throughout the soil. The minimum intervals (specified below) should elapse between application of **Clayton Launch** and the sowing of one of the following crops listed below.

5. Mixing and Application

5.1 Mixing

Never prepare more spray solution than is required. Half fill the tank with clean water and start the agitation. To ensure thorough mixing of the product, invert the container several times before opening. Add the required quantity of Clayton Launch to the spray tank while re-circulating. Fill up the tank with water and continue agitation until spraying is completed. When tank mixes are to be used, take due note of any instructions given as to the spray tank and fully dispersed before the addition of any further product(s). On emptying the container, rinse container thoroughly by using an integrated pressure rinsing device or manually rinsing three times. Add washings to sprayer at time of filling and dispose of Container safety.

This product may only be used in a tank mix or in sequence with other products when these uses comply with the label recommendations of every product in the tank mix/sequence.

5.2 Application

Ensure good, even spray cover of the target using a FINE or MEDIUM quality spray, as defined by BCPC. Apply **Clayton Launch** in 200-400 l/ha. Qualified recommendation Clayton Launch may be applied at 4 litres per hectare in 100 litres water per hectare although efficacy at this reduced volume has not been evaluated. Therefore application at 100 litres water per hectare is at user's risk with regard to biological efficacy.

5.3 Sprayer cleaning

After spraying, thoroughly clean and flush out application machinery with a minimum of three rinses, to ensure that all traces of product are removed.
