Use BALAYA as part of an Integrated Crop Management (ICM) strategy incorporating other methods of control, including where appropriate other fungicides with a different mode of action.

BALAYA should be used preventatively and should not be relied upon for its curative potential.

You must not apply more than two foliar applications of QoI containing products to any cereal crop.

There is a significant risk of widespread resistance occurring in *Ramulari collocyni* populations to a number of different modes of action. Repeated use of products containing the same mode of action are unlikely to provide effective control of this disease. BALAYA contains mefentriflucon zole a DMI function de. Resistance to some DMI functions has been identified in Serioria leaf bloch (*Mycosphaerella graminicola*) which may seriously affect the reformance of some products. There is a significant tick of when prend resistance occurring in *Septoria tritici* populations in Ireland. Failure to follow resistance management action may result in reduced levels of disease control.

To minimise the risk of resistance developing against *Septoria tritici*, BALAYA should be used in mixture with products from a different fungicide group to the triazoles or QoI at a dose that will give a robust control

BALAYA is a systemic fungicide with protectant properties for disease control in winter barley, spring barley, rye, triticale and oats.

Time of Application

For best results apply BALAYA as a protectant treatment or at first sign of foliar disease attack. A maximum of two application can be made up to and including flowering anthesis just complete GS 69) in barley, rye, triticale and oats.

Mixing and Application

Apply as a MEDIUM spray, as defined by BCPC.

Half fill the spray tank with clean water and start the agitation. SHAKE THE CONTAINER WELL before use and pour in the required amount of product. Rinse any empty containers thoroughly and add rinsings to the spray tank. Add the remainder of the water and continue agitation until spraying is completed.

When tank mixes are to be used, each product should be added separately to the spray tank, taking due note of any instructions given as to the order of mixing.

All tank mixes should be used immediately after mixing.
