OPERATOR PROTECTION

WASH HANDS/EXPOSED SKIN before eating and drinking and after wo WASH SPLASHES from skin or eyes immediately.

STORAGE AND DISPOSAL

DIRECTIONS FOR USE

ConShape is a growth regulator containing S-abscisic acid, that occurs naturally in plants. The product reduces the longitudinal growth of terminal shoots in Christmas tree (Abies nordmanniana) production.

Other specific restrictions:			

No more than one application per tree in a growing season.

WARNING

Do not use ConShape on Christmas tree species other than Abies nordmanniana. Do not make more than one application to any individual tree.

CROP SPECIFIC INFORMATION

A single application of ConShape should be made when the terminal leader is 20-30 cm long. Do not treat any terminal leader that are shorter than 20 cm.

For best results, apply ConShape under slow drying conditions. Avoid rain in the first 12 hours following treatment. Do not re-apply in the case of rain.

MIXING AND APPLICATION

ConShape is used without adding any surfactant.

Dilute 100 ml ConShape in 1 litre of water before application. Mix thoroughly before use.

Apply the diluted product with a roller ("Fasy Roller"). Place the roller at the base of the terminal growth and move upward in a continuous motion, applying about 2 ml of the diluted product to each tree. Apply uniformly to achieve full coverage of the terminal leader and prevent the liquid from running off. Insufficient coverage can reduce the growth control effect.

The top leader length can differ from tree to tree, requiring different application dates. Treated trees should be clearly marked to avoid re-treatment (e.g. by adding a dye to the treatment solution) and re-growth on individually selected trees should be measured.

Clean all application equipment thoroughly with water prior to storage or use on another crop.

STOPAGE

Do not reuse the packaging. Store in the tightly closed original container in a dry and cool place. Keep container in a well-ventilated place. Store separately from food, beverages, and feed. Keep away from incompatible materials (strong oxidizing agents).
