Revytrex should be used in accordance with the instructions for use for the target diseases at the specific growth stages indicated.

Use Revytrex as part of an Integrated Crop Management (ICM) strategy incorporating other methods of control, including where appropriate other fungicides with a different mode of action.

Revytrex should be used preventatively and should not be relied upon for its curative potential.

There is a significant risk of widespread resistance occurring in *Septoria tritici* populations. Failure to follow resistance management action may result in reduced levels of disease control.

There is a significant risk of widespread resistance occurring in *Ramularia collocygni* populations to a number of different modes of action. Repeated use of products containing the same mode of action are unlikely to provide effective control of this disease. Revytrex contains mefentrifluconazole, a DMI fungicide. Resistance to some DMI fungicides has been identified in Septoria leaf blotch (*Mycosphaerella graminicola*) which may seriously affect the performance of some products.

Crop Specific Information

Crops

Revytrex is a systemic fungicide with protectant and curative properties for disease control in winter barley, spring barley, triticale and rye.

Time of Application

For best results apply Revytrex as a protectant treatment. A maximum of two applications can be made from beginning of stem elongation (GS 30) up to and including flowering anthesis just complete (GS 69) in barley, triticale and rye.

A minimum interval of 14 days must be observed between applications.

Rate of Application

Apply 1.5 litres Revytrex in a minimum of 100 litres of water per hectare.

Mixing and Application

Apply as a MEDIUM spray, as defined by BCPC.

Half fill the spray tank with clean water and start the agitation. SHAKE THE CONTAINER WELL before use and pour in the required amount of product. Rinse any empty containers thoroughly and add rinsings to the spray tank. Add the remainder of the water and continue agitation until spraying is completed.

When tank mixes are to be used, each product should be added separately to the spray tank, taking due note of any instructions given as to the order of mixing.

All tank mixes should be used immediately after mixing.
