General Information

Nettleclear Ultra is a foliar acting herbicide for the control of NETTLES, DOCKS, THISTLES, BRAMBLES, BROOM and GORSE in established grassland and amenity grassland.

Safety precautions

Operator protection

- Engineering control of operator exposure must be used where reasonably practicable in addition to the following personal protective equipment:
- Operators must wear SUITABLE PROTECTIVE CLOTHING (COVERALLS), SUITABLE PROTECTIVE GLOVES, RUBBER BOOTS and FACE PROTECTION (FACESHIELD) when handling the concentrate.

Application timing:

- If the grass has been cut for hay or silage or grazed leave for 2-3 weeks to allow sufficient re-growth to occur before spraying. Grass and weeds must be actively growing to ensure good weed control and minimal check to the grass.
- · To allow for maximum translocation of Nettleclear Ultra to the roots, do not cut grass for 28 days after application.

Cleaning procedure:

 Wash out spray equipment thoroughly with water and detergent immediately after use. Traces of Nettleclear Ultra could cause harm to susceptible crops sprayed later.
