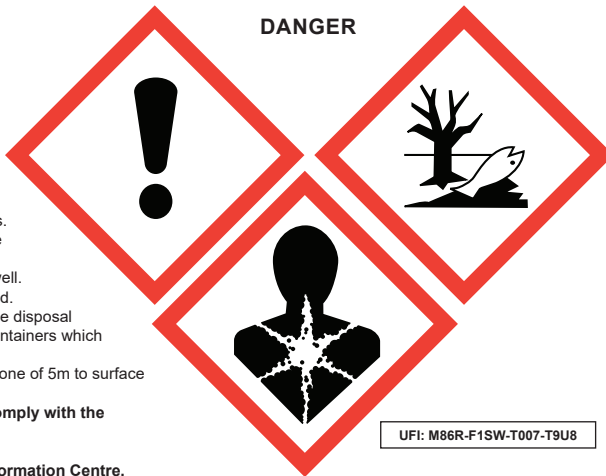

STORAGE

Store in a suitable pesticide store. Keep dry and protect from frost.

Yield response may be obtained in the absence of visual disease.

Time of Application

Apply **CONCERTINA** at the start of foliar disease attack. A maximum of two applications can be made up to and including flowering just complete in winter and spring wheat, rye and triticale and up to and including emergence of ear just complete in winter and spring barley and winter and spring oats.

Rate of Application

Apply 1.25 litres **CONCERTINA** in a minimum of 200 litres of water per hectare.

Resistance Management

- A maximum of 2 applications of any strobilurin type (QoI) product can be made to any cereal crop.
- In cereals this product must always be applied in a mixture with an approved fungicide that has a different mode of action. Both products must be applied at recommended rates.

Important Notes

1. Avoid spray drift on to neighboring crops.
2. Wash equipment thoroughly after use.

Mixing and Application

Method of application: Tractor mounted/trailed horizontal sprayer

Mixing: Half fill the spray tank with clean water and start the agitation. SHAKE THE CONTAINER WELL before use and pour in the required amount of product. Rinse any empty containers thoroughly and add rinsings to the spray tank. Add the remainder of the water and continue agitation until spraying is completed.

When tank mixes are to be used, each product should be added separately to the spray tank.
